HTA President Mr. Quarcelino asked that the Board not rush the reopening plan until the safety of teachers and students is guaranteed and teachers can be vaccinated. Mr. Grizzle, Mrs. Cartee and Mr. Abatti thanked the administration for their hard work on the reopening plan. Mr. Wells gave a monthly business briefing. It showed that there was an effective rate of return of 1.06% for the month ending December 31, 2020, and an effective rate of return for Fiscal YTD of 1.25%. There is now a cash balance of \$13 million due to the sale of the bond. He presented a few pictures of the progress of the HMS gym construction. The latest project completion estimate is May 2021. Mr. Ruiz reported that vaccines should be available soon to educators.

RESOLUTION AUTHORIZING ELECTION UNDER PUBLIC CONTRACT CODE SECTION 22030 TO BECOME SUBJECT TO UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING PROCEDURES)
THE GOVERNING BOARD OF THE HOLTVILLE UNIFIED SCHOOL DISTRICT DO HERE BY RESOLVE AS FOLLOWING:
WHEREAS, prior to the passage of Assembly Bill No. 1666, Chap. Stats. 1983, which added Chapter 2, commencing with Section 22000 to Part 3 of Division 2 of the Public Contract Code, existing law did not provide a uniform cost accounting standard for construction work performance or contracted by local public agencies; and
WHEREAS, Public Contract Code Section 22000 et seq., the Uniform Public Construction Cost Accounting Act, establishes such a uniform cost accounting standard; and
WHEREAS, the Commission established under the ACT has developed uniform public construction cost accounting procedures for implementation by local public agencies in performance of or in the contracting for construction of public projects; and
WHEREAS, the Holtville Unified School District desires to elect and become subject to Uniform Public Construction Cost Accounting Procedures for the purpose of awarding public project contracts as appropriate under these procedures; and
