#### **INFORMATION ITEMS**

Mr. Velazquez presented a PowerPoint on the EL Program & California Community Schools Partnership Program (CCSPP) update. The reasons for the modifications are because of the Differentiated Assistance findings and Ed Code Section 52163. The District-wide EL program will be reviewed next year by the Federal Program Monitoring (FPM). 45.6 % of HUSD students ae English Leaners; 12.8% are Reclassified Fluent English Leaners, and 15.9 % of EL students are Long Term EL. HUSD was awarded \$4,750,000 implementation grant for the next five years for the CCSPP Program. HUSD will hire 1 Psychologist, 1 Counselor, 2 Intervention Teachers, 1 School Nurse, 1 Nurse Clerk & 1 Secretary/Coordinator. Services provided will be Networking with ICOE Coordinators & CCSPP Coordinators; Professional Learning for teachers and staff; Weekly SEL check-ins for students.

#### **ACTION/DISCUSSION ITEMS**

Moved by Trustee Garewal, Seconded by Trustee Abatti to approve 2021-22 Measure G Bond Audit. Mr. Wells stated that this item is a legal requirement, as the Measure G Bond was a Prop 39 ballot measure. The main component of the audit is to ensure that the District is meeting all of the Prop 39 requirements. The auditor did not issue any findings, verifying the District's compliance. Passed by unanimous votes Ayes: 4, Nays: 0. Moved by Trustee Abatti, Seconded by Trustee Duarte to approve Board Resolution 2022/23-013 to Authorize Temporary Borrowing Between Funds of the School District. Mr. Wells explained that this is an annual action item we do to ensure that we have a borrowing mechanism in place in the event any of our funds is experiencing a cashflow issue. This allows the District to do short-term lending from one fund to another to ensure that payroll and commercial warrants are not withheld. Moved by Trustee Garewal, Seconded by Trustee Abatti to approve Board Resolution 2022/23-014 Approval of Participation in Bids/Contracts of Other Public Agencies (Piggyback Contracts); Authority to Award Piggyback Contracts. Mr. Wells explained this resolution allows the District to participate in piggyback bids, which are contracts issued by other public entities for equipment and services that have already gone through the public bidding process. This streamlines and simplifies the process for other public entities like us and allow us to conduct business more quickly. Roll Call Vote: Grizzle; Aye: Garewal; Aye; Abatti; Aye: Duarte. **GENERAL BUSINESS** 

#### AGREEMENT FOR LEGAL SERVICES

This AGREEMENT is entered into by and between the HOLTVILLE UNIFIED SCHOOL DISTRICT (hereinafter "DISTRICT") and the law firm of CURRIER & HUDSON, a Professional Corporation (hereinafter "ATTORNEYS"), a law corporation registered with the State Bar of California and the California Secretary of State.

ATTORNEYS agree to provide legal services to and legal representation for the DISTRICT in regard to various matters and litigation in the area of employer/employee relations, labor relations, personnel administration, pupil rights and responsibilities, general operations, and educational and related issues, when requested by the DISTRICT and agreed to by ATTORNEYS. Nothing herein is to be construed as an exclusive agreement preventing or otherwise discouraging DISTRICT from employing other attorneys when desired and for whatever purposes. The statutory authority for this AGREEMENT is contained in Government Code section 53060 and various provisions contained in the Education Code.

The DISTRICT agrees to compensate ATTORNEYS for legal services at the following hourly rates: \$250 for Partners/Senior Counsel and \$225 for Associates.

ATTORNEYS will bill legal work performed in increments of 1/10th of an hour unless some alternative arrangement, such as a single fee, is agreed to between the parties in writing. The DISTRICT agrees to compensate ATTORNEYS for ordinary reasonable costs and expenses to include, but not limited to, travel time, mileage at the current Internal Revenue Code reimbursable rate, postage in excess of that for routine correspondence, and fees for court filing and service of process. Such expenses shall be charged at the rates actually charged to ATTORNEYS. ATTORNEYS do not charge for long distance telephone calls, faxing of documents, or routine postage and copy costs.

In the event there is a continuing dispute regarding fees or costs billed by the ATTORNEYS, either party may resolve such dispute by submitting it to binding arbitration conducted by the American Arbitration Association.

ATTORNEYS agree that they are independent contractors and not employees of the DISTRICT, and that ATTORNEYS are licensed by and in good standing with the State Bar of California. ATTORNEYS maintain Lawyers Professional Liability insurance coverage in the amount of \$1,000,000/\$4,000,000 aggregate and other coverages required by law, including Workers Compensation in the amounts required by law.

The term of this AGREEMENT shall commence on July 1, 2023, and continue through June 30, 2024, and from month to month thereafter until terminated by either party. Either party may terminate this AGREEMENT at any time upon ten (10) days prior written notice from the party seeking termination to the other party, without cause and at any time during the term herein or any extension of such term.



## HOLTVILLE UNIFIED SCHOOL DISTRICT RESOLUTION NO. 2022/23-015

## REGARDING THE 2023-24 EDUCATION PROTECTION ACCOUNT

WHEREAS, the voters approved temporary sales and income tax increases with Proposition 30 on November 6, 2012; and voters approved Proposition 55 on November 8, 2016 which allowed the sales tax increase to expire in 2016 while extending the increased income tax rates through 2030.

WHEREAS, Proposition 30 added Article XIII, Section 36 to the California Constitution effective November 7, 2012; and Proposition 55 amended Article XIII, Section 36 of the California Constitution effective November 8, 2016 and commencing on January 1, 2018.

WHEREAS, the provisions of Article XIII, Section 36(e) create in the State General Fund an Education Protection Account to receive and disburse the revenues derived from the incremental increases in taxes imposed by Article XIII, Section 36(f) of the California Constitution;

WHEREAS, before June 30<sup>th</sup> of each year, the Director of Finance shall estimate the total amount of additional revenues, less refunds that will be derived from the incremental increases in tax rates made pursuant to Article XIII, Section 36(f) that will be available for transfer into the Education Protection Account during the next fiscal year;

WHEREAS, if the sum determined by the State Controller is positive, the State Controller shall transfer the amount calculated into the Education Protection Account within ten days preceding the end of the fiscal year;

WHEREAS, all monies in the Education Protection Account are hereby continuously appropriated for the support of school districts, county offices of education, charter schools and community college districts;

WHEREAS, monies deposited in the Education Protection Account shall not be used to pay any costs incurred by the Legislature, the Governor or any agency of state government;

WHEREAS, a community college district, county office of education, school district, or charter school shall have the sole authority to determine how the monies received from the Education Protection Account are spent in the school or schools within its jurisdiction;

WHEREAS, the governing board of the district shall make the spending determinations with respect to monies received from the Education Protection Account in open session of a public meeting of the governing board;

WHEREAS, the monies received from the Education Protection Account shall not be used for salaries or benefits for administrators or any other administrative cost;

WHEREAS, each community college district, county office of education, school district and charter school shall annually publish on its Internet website an accounting of how much money was received from the Education Protection Account and how that money was spent;

WHEREAS, the annual independent financial and compliance audit required of community college districts, county offices of education, school districts and charter schools shall ascertain and verify whether the funds provided from the Education Protection Account have been properly disbursed and expended as required by Article XIII, Section 36 of the California Constitution;

WHEREAS, expenses incurred by community college districts, county offices of education, school districts and charter schools to comply with the additional audit requirements of Article XIII, Section 36 may be paid with funding from the Education Protection Act and shall not be considered administrative costs for purposes of Article XIII, Section 36.

## NOW, THEREFORE, IT IS HEREBY RESOLVED:

- 1. The monies received from the Education Protection Account shall be spent as required by Article XIII, Section 36 and the spending determinations on how the money will be spent shall be made in open session of a public meeting of the governing board of <u>June 20, 2023</u>;
- 2. In compliance with Article XIII, Section 36(e), of the California Constitution, the governing board of the Holtville Unified School District has determined to spend the monies received from the Education Protection Act as attached.
